

Home Care Client Fees

Calculation of Client Charges

Effective October 1, 2019

There is no fee for services provided by a nurse, social worker, physical therapist or occupational therapist. Charges apply for Continuing Care Assistants (CCA's) and/or Meals on Wheels.

One (1) unit is considered to be one hour of time or one meal. For chargeable services, all clients pay \$8.56 per hour for the first ten (10) hours in a month. After 10 hours in a month, the client will be charged a rate per unit that corresponds to the client's adjusted monthly income.

Charges for CCA visits are in 15 minute increments. You will only be charged for the period of time scheduled. Meals on Wheels are charged as one full unit.

Please refer to the following chart to determine the monthly charge after 10 hours of service. The Adjusted Monthly Income can be found on your completed subsidy form.

Instructions for Calculation of Income Tested Subsidy

General

Refer to your Canada Revenue Agency (CRA) Notice of Assessment to complete the Home Care Subsidy Application. Only the income of the applicant and spouse (if residing with the applicant) should be included. If the client is under 18 years of age, the income of the parents or guardians should be used for the subsidy application.

Annual Income

Enter the amount from line 236 for both the applicant and spouse.

Deductions

Enter the amount from line 435 for both the applicant and the spouse.

Exemptions

Enter the following:

1. Basic exemption - \$1,632.00
2. Spousal exemption - \$1041.00
3. Dependent child under age 18 - \$468.00
4. First dependent child under age 18 in a single parent family - \$1041.00

If a single parent claims the spousal exemption amount of \$1041.00 for one child, that child cannot also receive the dependant exemption of \$468.00
